LETTER FROM THE EXECUTIVE SECRETARY

With a degree in horticulture, I am eager for the fresh emerging life of spring. Seasons provide a natural cycle of growth, fulfilling life, dormancy, and regeneration. Surface growth, greenery, and exquisite

blooms can be most beautiful, but the deeper mystery and excitement happens below the surface. Plant health is frequently affected not by what is seen, but by what is unseen. A favored garden only happens with significant attention to soil quality, pH balance, and nutrients – ultimately delivering an environment for high quality root growth. When plants are dormant above the surface, the roots are actively growing, developing energy needed to sustain and perpetuate life.

Organizational growth follows the same seasonal cycles. We are in a season of deep strategic work at The Foundation – a season of soil cultivation and deep subsurface growth. Many of you recently participated in what I believe might be our first community perception survey since our establishment in 1925. We are grateful to you for investing your time and voice as we work towards supporting purpose, inspiring growth, and building the future of Van Wert County and surrounding region. As a direct result of your input, we have identified five pillars that we will be developing over the next several months. They include Mission and Vision; Stewardship and Impact; People (board, staff, and constituents); Finance, Fundraising and Sustainability; and Community Leadership and Programs. We are eager to show off the exquisite emerging life that is developing because of this cultivation. A deeper look into this process will be unveiled in our upcoming Annual Report.

Another seasonal change is upon us. We are grateful for the work of our friend and employee Paul Hoverman. On May 6, Paul will retire from his work with us as Coordinator of Performing Arts for The Foundation and as Executive Director of The Niswonger Performing Arts Center. 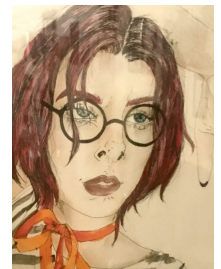
A CATALYST FOR CREATIVE EXPANSION

RECENT GRANT AWARDS

MIDDLE POINT PARK



The Middle Point Recreation Association, has a sense of enthusiasm about the major renovation projects that have been going on in the Middle Point Park.

It all started a couple of years ago when the association received a large capital improvements grant from the State of Ohio then coupled with contributions from The Foundation.

From 2016 to date, VWCF has awarded \$20,850 in competitive grant dollars to The Middle Point Recreation Association for improvements to the Middle Point Park.

Monies from the grants enabled officials to put in six new dugouts, replace fencing, construct a new shelter house, complete with restrooms and install new basketball goals. Another grant cycle enabled the association to resurface the basketball courts, do a sidewalk project that included handicap access, placement of eight benches and lights to illuminate the walkway geared for those seeking to utilize it for health reasons.

Most recently, the association was able to acquire an old brick structure south of the railroad tracks on Adams Street that was constructed in the early 1900's. Plans are to restore the building to use for meetings and add batting cages.

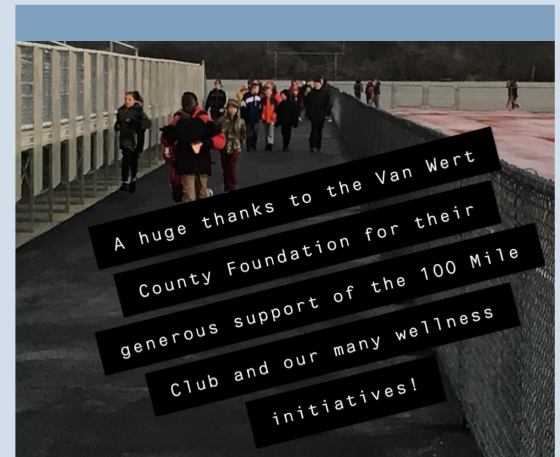

INSPIRING GROWTH

COMMUNITY IMPACT INVESTING



FOUNDATION SUPPORTS ECONOMIC DEVELOPMENT PROGRAM

Recently, VWCF facilitated a community impact investment loan for \$100,000 to Van Wert Area Economic Development to fund the upfront costs of administering the land bank program in Van Wert County. This is interest-free working capital and has a low half-percent administrative services fee.

The Van Wert County Land Reutilization Corporation which operates alongside area economic development, is focused on facilitating the transition of blighted, vacant, and abandoned properties into viable, marketable properties by working collaboratively with public and private entities in a financially responsible, transparent manner with a long-term goal of returning these properties to the tax roll or other greater public purpose.

In its two years of existence, the land bank has acquired 51 properties throughout the county and revitalized 47 that were vacant and blighted. The land bank has received \$1.15 million in federal grant funds since it was formed in 2017. Properties that have been improved are located in the city of Van Wert and the villages of Willshire, Middle Point, Venedocia, Ohio City, and Convoy. Land bank activity has led to a decline in the county's tax delinquency rate from 2.7 percent in 2016 to 1.3 percent in 2018.

"The Van Wert County Land Bank is focused on facilitating the transition of blighted, vacant, and abandoned properties into viable, marketable properties. The goal is to return properties to the tax roll or other greater public purpose and stabilize property values in our neighborhoods. We appreciate the support the VWCF has provided to the program by giving access to temporary working capital, enabling us to address more properties and positively impacting more neighborhoods." states, Stacy Adam, Executive Director of Van Wert Area Economic Development.

Proceeds from the sale of the properties are returned to the Neighborhood Initiative Program, the federal grant program administered by the Ohio Housing Finance Authority. Proceeds from properties sold more than three years after the land bank acquired them is returned to the local land bank.

VVHS ROBOTICS PROGRAMS FOR SUCCESS

The Robotics program is a recent competitive grant recipient of \$2,000 from the William J. Flickinger Memorial Trust.

This fund is a "multi-purpose" fund meaning the income is distributed several different ways as directed by the donor, part designated and undesignated.

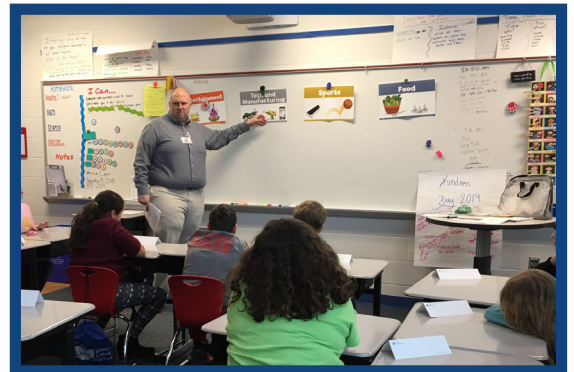
Junior Achievement empowers young people to own their future economic success by enhancing the relevancy of education. At every grade level JA programs expose students to basic business concepts and the skills that enable them to understand real-life economics. With this knowledge, they build an understanding regarding economic choices and the resulting consequences of each decision. This prepares them for economically independent futures based on strong economic knowledge and solid personal financial management skills.

More than 1,500 young people in Van Wert County schools are building economic knowledge and personal financial literacy through JA programs during this school year. The learning is possible because of grant funding through The Van Wert County Foundation.

A total of \$3,750 in competitive grant funds were awarded to JA of Van Wert County in 2018 supported through the Fred W. & Kathleen M. Wollenhaupt Memorial Fund and the Charles E. & Velma R. Egress Memorial Fund. Both funds are "undesignated" which means that the distribution of income is determined by the VWCF Board of Trustees.

In partnership with educators, local adult volunteers deliver professionally developed learning activities and share their experiences with students. They are igniting the spark in young people to experience and realize the opportunities and realities of work in the global marketplace.

CHARITABLE TRUSTS

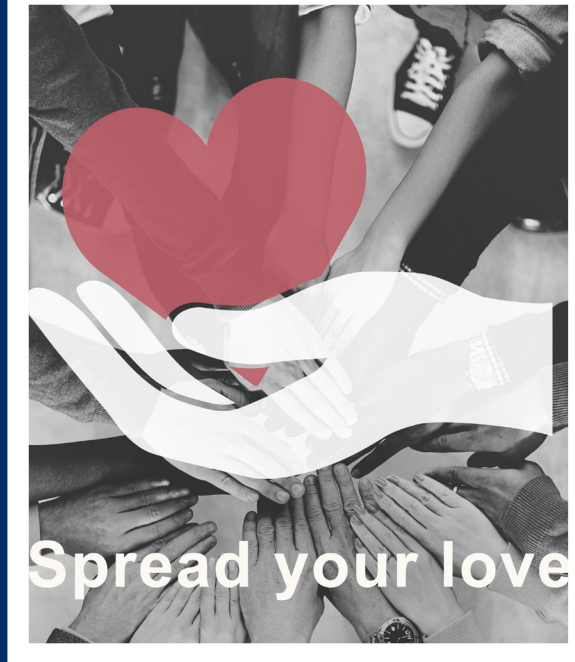
Charitable giving, through trusts, normally involves one of two types of trusts; the charitable remainder trust or the charitable lead trust. There are many variations of each, but the principals are the same; property is placed into a trust, income is generated for the duration of the trust, and at the end of the trust, the principal is distributed to the proper beneficiary.

LIFE INSURANCE GIFTS

A gift of a life insurance policy with The Foundation named as owner and beneficiary can be a particularly effective way for a donor to make a gift. A donor of insurance can obtain an income tax deduction in the year the gift is made. A new policy may also be written with The Foundation as the beneficiary, and a tax deduction can be obtained.

TRUSTS, WILLS, AND BEQUESTS

Trusts, wills, and bequests are used to assure the wishes of the donor are carried out specifically, and that activities supported by the donor during his or her lifetime, continues to be funded in the future.

Stober's hiring will kick off a plan for strategic growth in programming, development, and community outreach.

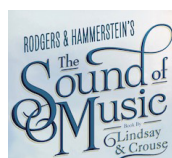
